It is probably the most delicate case that is currently dismantled by domestic justice. The investigator is interested in under what circumstances a secret service - the Office for Foreign Relations and Information (UZSI) - bought six eavesdropping devices known as Agata, and why she invested in a private company CyberGym Europe.

The case is accompanied by strict confidentiality. Intelligence falls under the Ministry of the Interior as well as its budget chapter. Metnar, who moved to the post of Defense Minister in the current cabinet, ordered his in-depth audit in January. There followed a criminal complaint due to the allegedly uneconomic treatment of funds amounting to up to three quarters of a billion crowns. In May, Metnar set up the secret service director, George Sasek, out of service. Ex-Chovanec, says he is not responsible for the management of the intelligence service. "I do not have the information about what the Minister signs (confessing secrecy).
